CHAPTER 1 - STANDARD REQUIREMENTS

1 EVENT TITLE, DATE & VENUE

The event shall be known as the WASCC Jack's Hill Hillclimb to be held on Saturday 26 April 2008 at Jack's Hill, Wattle Avenue, Neerabup.

2 ORGANISATION AND STATUS

- (a) The event shall be held under the International Sporting Code of the Federation Internationale de l'Automobile (FIA), the National Competition Rules (NCR) of Confederation of Australian Motor Sport Ltd (CAMS), the Speed Event Standing Regulations, WA Speed Event Series Regulations, these Supplementary Regulations and any further Regulations and instructions to Competitors that may be issued.
- (b) This event will be conducted under and in accordance with the CAMS Risk Management and OH&S policies, which can be found at www.cams.com.au
- (c) The event shall be a Multi Club Single Car Speed Event.

4 CIRCUIT DETAILS

- (a) **Length:** 1200 m
- (b) **Surface:** Asphalt.

5 ENTRIES

- (a) **Opening date:** Entries open on publication of these Regulations.
- (b) **Closing date:** Thursday 24 April 2008.
- (c) **Entry fee:** \$90.00 per driver (inclusive of GST) payable to the WA Sporting Car Club.
- (d) **Entry lodgement address:** PO Box 267, WANNEROO WA 6946.
- (e) **Restricted entries:** The organisers will restrict entries to 80 participants and reserve the right to refuse any entry without assigning any reason therefore in accordance with NCR 83.

7 STARTING AREA - IMPORTANT - PLEASE NOTE

The start area on this course slopes slightly downhill. If possible, vehicles will need an operative handbrake to accomplish effective starts. No person is permitted to hold a vehicle.

8 START/NUMBER OF RUNS

- Competitors will be split into two groups, predominately based on class. Competitors will be advised which group they are in at the driver's briefing.
- Practice will commence at 0930 hrs. Each competitor will be allotted one dot sticker placed on window where possible for the practice run. Practice times do not count for results.
- The event is scheduled to start immediately following practice. Four runs shall be given to each competitor. Each competitor will be allotted four dots for timed runs. One sticker will be removed for each completed run.
- In each group cars will run in any order as they line up. The onus is on each competitor to make sure they have their allocated number of runs.
- There shall be a lunch break at approximately 1230 hrs.
- The event is scheduled to finish at approximately 1630 hrs.

9 LICENCE REQUIREMENTS AND LOG BOOK REQUIREMENTS

Competitors must hold a minimum of a CAMS Level 2S or 2SJ Licence and be a member of a CAMS Western Australian affiliated Car Club. Competitors may obtain a CAMS Level 2SE Licence, however, this Licence is only valid for one event.

10 PARENTAL CONSENT

If any competitor or driver is under 18 year of age the consent of his/her parent or guardian must appear on the Entry Form.

11.2 Procedure

Inspection is to be conducted in the week prior to the event concerned. Competitors must ring the person they want their car inspected by, and arrange an inspection time. Scrutiny can only be carried out for metropolitan competitors in the week prior to the event and only at the above locations **by appointment. No scrutiny of metropolitan vehicles will be available at the venue prior to the event, unless the vehicle is unregistered (trailed) to the venue.**

Should a metropolitan competitors vehicle be presented at the circuit on the day without having passed scrutiny a \$50 fee will apply (payable on the spot) and the Event Organisers reserve the right to refuse to check the vehicle in question, or place it at the rear of the scrutiny line.

The inspection point will have scrutiny forms. The forms have a tear off section at the bottom which will be endorsed by the inspector, and the Competitor is to present it at registration on the day of the event. The main body of the form will be completed by the scrutineer, and will be delivered to the organiser.

11.3 Country scrutiny arrangements

On the day scrutiny will commence at 0800 hrs and conclude at 0900 hrs at the venue.

11.4 All Competitors

- (a) Your helmet must be presented for inspection and approval at time of scrutineering.
- (b) Membership cards and appropriate CAMS Licence, and log book (if applicable) must be produced during scrutiny and on request during the meeting.
- (c) Race numbers will be provided on the day.
- (d) No car may participate unless it has passed scrutiny.
- (e) Any car which, after approval, is dismantled or modified in any way which might affect the safety of the vehicle or raises questions as to its eligibility, or is involved in an accident having similar results, must be re-submitted for scrutiny for approval prior to any further participation.
- (f) Any car or driver may be prohibited from practice or the competition for safety reasons.

12 COMPETITORS' BRIEFING

A Competitors' Briefing at 0915 hrs will be held at the top of the course. All competitors MUST sign on. Any competitor failing to attend or arriving late at the Briefing should seek out the Clerk of Course who will consult with the Stewards to determine whether they are permitted to run and under what conditions, e.g. reduced number of runs.

13 AUTOMATIC TIMING

All vehicles will require a Dorian Data-1 timing transmitter to be fitted prior to the commencement of practice. Competitors who do not have a transmitter will be issued one at Registration. The mounting of the transmitter is the responsibility of the competitor and cable ties will be required. It is the competitor's responsibility to cover any costs related to repairs and or replacement of the transmitter if lost or damaged. Competitor are to return the transmitter to the timekeepers at the conclusion of your final run.

14 INSURANCE

Combined Liability Insurance has been effected by the Promoters. All Competitors and officials are covered by the Motor Sport Personal Accident Insurance Policy. For further details, see

Appendix I of the CAMS Manual of Motor Sport. Every competitor and driver before taking part in any competition shall sign the Disclaimers and Competitors Statement on the Entry Form.

15 PROTESTS

Any protest must be lodged in accordance with the Provision of Part XII of the NCRs.

16 POSTPONEMENTS, ABANDONMENT OR CANCELLATION OF COMPETITION

The Organisers reserve the right to abandon the event in accordance with the Provisions of NCR 59.

17 USE OF PROHIBITED SUBSTANCES

- (a) During any competition, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Procedure for Alcohol Testing and CAMS Drugs in Sport Policy.
- (b) Other Prohibited Substances
The CAMS Drugs in Sport Policy, as appears in the current CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such.
In any areas where the National Competition Rules and the Drugs in Sport Policy conflict, the Drugs in Sport Policy will take precedence.
Competitors, crew or officials may be tested for alcohol or other drugs at any time during the event(s). This regulation serves as the required 24-hour notice to Competitors, Crew and Officials.

18 DETERMINATION OF WINNERS AND AWARDS

The results will be determined by the fastest overall time (lowest elapsed time) of the day not including the practice run and ranked in ascending order of time. Should two or more competitors record the same time the competitor next best fastest time shall determine the winner.

19 APPAREL

All Competitors must wear helmets and in open vehicles, goggles/visors complying with a standard as listed in Schedule D of the current CAMS Manual of Motor Sport. CAMS recommend that competitors wear an approved full-face helmet when driving in open vehicles (refer Schedule D of the current CAMS Manual of Motor Sport). Fire resistant clothing is recommended, otherwise, Competitors must wear woollen or cotton clothing covering the body from ankles to wrists and neck, and suitable and appropriate footwear.

20 SAFETY - CARS

The attention of competitors is drawn to Schedules A & B of the General Requirements of Automobiles found in Section Six and the Standing Regulations for Speed Events in the current CAMS Manual of Motor Sport.

All cars must:

- (a) Be fitted with Seat Belts to AS E35 or of a type specifically approved for use by CAMS.
- (b) Have a securely fitted fire extinguisher, which complies with AS 1841 (save that extinguishers which meet AS1841.2 are not permitted). The Chief Scrutineer will be paying special attention to mounting brackets for fire extinguishers. We recommend that competitors discard plastic brackets in favour of metal ones, which should be mounted in a suitable position and of a type and capacity as specified in Schedule H, of the CAMS Manual of Motor Sport. The fitment of an 'on board' system approved for use by CAMS is an acceptable alternative.

- (c) Having, on the external coachwork, a blue triangle of sides 150mm, this indicates the position of the battery.

Cars not road registered must:

- (a) Be fitted with a scatter shield if required under the provisions of Schedule M of the current CAMS Manual of Motor Sport.
- (b) Not be fitted with any steering column locking device.
- (c) If not equipped with a suitable cross member then to be fitted with a strap that will prevent the tail shaft falling to the ground in event of a component failure.
- (d) Be fitted with crankcase breather/s discharging to atmosphere have fitted to such breather/s an oil trap container which must be empty at the start of competition, of a capacity of at least two litres for vehicles under 2000cc or three litres for vehicles over 2000cc.

The use of recapped or reconditioned tyres is forbidden. Tubeless tyres must be fitted to optimum rim size only. Fuel must be 'Commercial Fuel' as defined by CAMS, Schedule G of Section 6 of the current CAMS Manual of Motor Sport. Roll bars are not compulsory in closed speed events, but are recommended. All cars must be adequately muffled.

21 COMPLIANCE WITH INSTRUCTIONS

Failure to follow the direction of any official will render a competitor liable to exclusion.

22 COURSE ENTRY, ACCESS AND VIEWING

- (a) All vehicles will enter off Gate 1 (Main Entrance) on Wattle Ave and proceed left behind Warren's Ultra Fast Kart building to the top of the Hill Climb course along the unsealed road.
- (b) Pedestrian access is only available via the Perth Soapbox Gate adjacent to the start line.
- (c) All non-competition vehicles (tow vehicles and trailers etc.) must be parked on the limestone area to the west of the asphalt marshalling area at the top of the course.
- (d) All competitors and pit crew must note that there is limited viewing access on this course. Viewing is only possible from the asphalt marshalling area at the top of the course and adjacent to the start line at the bottom of the course. There is no pedestrian or vehicle access from the top to the bottom of the course except via Wattle Avenue.

23 PRESENTATION

Awards will be presented at the conclusion of the event at approximately 1700 hrs.

24 CATERING

Food and refreshments will be available at the Perth Soapbox Club Kiosk adjacent to the Start Line with a drinks service available at the top of the hill. All present are encouraged to support our friends from the Perth Soapbox Club.

25 DRIVER CONDUCT

Any driver who

- (a) Cuts corners, OR
- (b) Dislodges corner markers(s), OR
- (c) Sprays quantities of dirt or gravel on the racing surface
- (d) Fails to complete the course in full

May have five (5) seconds added to the time for the lap/run that the incident takes place on. Furthermore, drivers who persist in such behaviour may be excluded from further competition. The Clerk of Course and their assistants and other officials appointed at the event by the Clerk of Course shall be a judge of fact for such incidents.
